
The Argument

- Devolution was intended to strengthen the UK
- Would demonstrate that the UK state could recognise and meet the distinctive needs, aspirations and identities of Scotland & Wales
- (and create opportunities for the better government of England)
- But in recognising difference might devolution stimulate and politicise it?
- Meanwhile, questions of identity and difference also raised by Brexit



Forced Choice National Identity Scotland: 1974-2017





Moreno National Identity: Scotland (Selected Years)







Moreno Identity in Wales





English or British?






Identity

- Devolution was a recognition of an existing distinctive sense of Scottish/Welsh identity
- With the exception of England in the late 1990s, not clear that British identity has weakened in the wake of devolution in any part of Britain
- Many still feel 'British and...'

An Alternative Approach


- Which of the statements on this card comes closest to your view about who should make government decisions for Scotland?




The English Devolution Debate

- Regional devolution rejected in NE referendum in 2004
- City Regions Revival of old (little loved?) structures (Greater Manchester, Avon etc.)
- Directly elected mayors outside London not proven very popular when put to voters in referendums
- Impetus from Scottish independence referendum EVEL/English Parliament


Forms of Devolution




Scots MPs not vote in English Laws?







England on Scotland





Preferences

- The debate in England remains fragmented.
- Despite a clear sentiment against the involvement of Scottish MPs in English laws – little sign of any sustained backlash against Scottish devolution
- Wales has come to embrace its assembly but still little support for independence
- Support for independence in Scotland has grown in the wake of the 2014 referendum



% Leave, 2016 Referendum





Link between English Identity and Euroscepticism Predates Brexit








A Mobilised Identity?


Identity and Preference in Wales

How Brexit Created A New Divide





Mobilising Identity

- Despite a (longstanding) link between attitudes towards Brexit and English identity, the debate about how England should be governed only has a (continuing) weak link with identity
- In contrast constitutional preference is linked with identity in Scotland & Wales
- In Scotland the growth in support for independence has occurred primarily among those with a strong Scottish identity
- Brexit has added a new dimension to the independence debate in Scotland

Conclusion

- Wales has embraced a devolution that reflects
 Welsh identity, but still shows little sign of seeking independence. Devolution succeeded?
- The devolution debate in England is fragmented and attitudes continue to have little link with identity. Devolution stalled?
- In Scotland devolution has created a pathway to greater support for independence that has mobilised a distinctive identity – and has now been further fuelled by Brexit. Devolution failed?
